Thank you for your March 27, 2018, memorandum providing comments on our March 23, 2018, eligibility determinations.

Given the lack of information on the interiors of the Blythe Homestead (MK1457), we believe that the best course of action is to consider the property not eligible for listing in the National Register unless the owner can provide the information needed to cause NCDOT and us to reconsider a "not eligible" determination.

We appreciate and concur with your revised boundary for the Stillwell-Hubbard complex, Stillwell-Hubbard House (MK3692). We will add the boundary you provided to our GIS and Statewide Survey databases.

The above comments are made pursuant to Section 106 of the National Historic Preservation Act and the Advisory Council on Historic Preservation's Regulations for Compliance with Section 106 codified at 36 CFR Part 800.

Thank you for your March 23, 2018 response to the above-referenced project. We offer the following comments:

Blythe Homestead (MK1457)- As stated on page 58 of the report and within the response letter, access to the property was not available to our consultants. Please advise us on the eligibility of the property under Criterion C based on the information available at this time.

Caldwell Rosenwald School (MK1461)- We concur that the school is not eligible for National Register listing.


Gilead ARP Church (MK1465)- We concur that the church is not eligible for National Register listing.

**Stillwell-Hubbard Complex-** We concur with your assessment of the boundary, and propose that the boundary crosses Brown Mill Road and Beattie's Ford Road to connect to the parcels north of the main complex. I have attached a figure and an appropriate GIS boundary for use on the GIS website.
