Thank you for your memorandum of September 21, 2018 with additional comments on the survey report, and we offer the following comments and information for your records.

Oak Grove Methodist Church & Cemetery

We concur with your finding that the Oak Grove Methodist Church & Cemetery (TV0415) is not eligible for National Register listing based on the information provided; it lacks integrity and significance necessary for National Register eligibility.

### Sims Art Center

Thank you for your comments on the Sims Art Center. Built 1970, the building is not old enough to warrant evaluation and was therefore not surveyed. The Sims Art Center is one of only two Brevard College structures within the Area of Potential Effects (APE) for this project, the other being the Porter Center built 1998. As stated in your memorandum, the historic core of the college lies south of the APE, and the proposed access management improvements along U.S. 64 begin in front of the Sims Art Center and run north and therefore the historic portion of the college will not be affected by this project.

### **Lutheran Church of the Good Shepherd**

It was confirmed through communication with the church that the original building on the site was completed September 1960. Although the modernist design of the original structure is unique, since its construction it has received several incompatible additions to the rear (northwest) portion of the building in 1970 and 1984, and most recently 2001, at which time the present sanctuary, commons, and memorial garden were constructed as noted on the congregation's website. The attached additions quadruple the size of the church and diverge in style and materials from the original 1960 sanctuary; the three additions also vary in style and materials as well. The church has lost integrity of design, feeling, and setting, and is therefore not eligible for National Register listing.
