RE: Historic Structures Survey Report, Upgrade Existing NC 191 (Brevard Road) from NC 146 (Long Shoals Road) to North of the Blue Ridge Parkway, U-3403B, PA 17-09-0012, Buncombe County, ER 18-1113

As I mentioned in my January 9, 2019 letter concerning the project referenced above, the northern portion of the project area was expanded after the April 2018 survey requiring the study of one additional potential historic resource. At this time, I can report that the Bent Creek Baptist Church and Cemetery has been evaluated and determined not eligible for the National Register of Historic Places due to changes in the integrity of the historic sanctuary and lack of significance of the site. The Bent Creek Baptist Church and Cemetery is a ten-acre campus comprised of three structures: a 1921 frame sanctuary, a 1980s brick fellowship hall, and a 1989 masonry sanctuary.

According to the church staff, the 1921 structure was moved when Brevard Road was improved in the 1970s and as a result, some of the cemetery markers nearly abut the former sanctuary. Services moved from to the larger masonry sanctuary in 1989 and the 1921 building was heavily remodeled with the removal of the balcony, altar, and pews in the late 1990s. Also covered in artificial siding, staff conveyed that the structure is currently used as a recreation/multi-purpose center but did not allow entry for confirmation. The cemetery markers are mostly stone with mass-produced designs and forms with dates ranging throughout the twentieth century. There are no persons of historic significance associated with the church or the cemetery, nor are there any significant historic events associated with the site or the congregation. Images of the site and structures are included as an attachment to this letter.

The Bent Creek Baptist Church and Cemetery does not retain integrity of design, materials, workmanship, or feeling because the essential physical features of the 1921 sanctuary have been lost. The integrity of location and setting has been compromised as well. Finally, while it remains associated with the congregation, the sanctuary does not convey a direct link between events associated with the site's history. Furthermore, the Bent Creek Baptist Church and Cemetery does not meet any of the criterion for significance, including Criterion Consideration A for religious properties. Please review this analysis and the attached images and provide your comments on the evaluation.

In summary, at this time, our offices agree that the APE contains the following properties that are either listed in or eligible for the National Register of Historic Places:

- 1. Pisgah Forest Pottery (BN0594) Criteria A, B, & C
- 2. Blue Ridge Parkway (NC0001) Criteria A & C
- 3. Bent Creek Campus (BN0898) Criteria A & C

I will include the eligible resource on the design plans and will schedule an effects assessment meeting with your office in the near future.
