Thank you for your letter of April 21, 2003 concerning the Historic Architectural Resources Survey Report for R-3302. In that letter you requested a re-evaluation of the National Register-eligible boundaries for the Stoney Run Historic District because you believed them to be too large for Criterion C, architecture. In response to your request, we have adjusted the boundaries of the Stoney Run Historic District. The new boundaries, as indicated on the attached map, encompass approximately four-four acres of six tax parcels and follow the existing right-of-way along NC 53. NC 53 bisects the district but is not a contributing elements of the district, nor is the small section of SR 1343 that is included in the district. The new National Register-eligible boundary includes the original site of the John Wright Bowen House and three later houses as well as some of the acreage associated with the houses. These boundaries should provide an adequate setting to demonstrate the district's significance for architecture. The remaining acreage within the current tax parcels contains no contributing resources and does not play a part in the district's significance

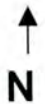

Two years ago the North Carolina Department of Transportation conducted a study of historic architectural resources in the proposed Burgaw Bypass project area. The study evaluated the Stoney Run Historic District, a property added to the North Carolina State Study List following the 1998 survey of Pender County. As detailed in our March 2003 report, the district is eligible for the National Register of Historic Places under Criterion C for architecture.

Your office agreed with the eligibility finding, but requested an adjustment of the suggested National Register boundaries so that the district might conform more precisely with the Criterion C characteristics. Accordingly we submitted new boundaries (in a letter dated May 5, 2003), significantly reducing the district in size and including only the four key houses, their outbuildings, and their immediate acreage. On the map attached to the letter we inadvertently squared off the boundary at the southwest end of the district north of NC 53, thus including a property originally and correctly left outside of the eligible area.
